### **VOLUNTEER AGREEMENT WITH NORTH OKALOOSA FIRE DISTRICT**

This agreement is entered into this	day of	, 20	between the North

a prospective volunteer fire and rescu	e applicant.		

This agreement is entered into in order to fully and completely define the expectations of the volunteer and to fully and completely outline the rewards, incentives, values and recognitions that the volunteer may expect from the department in return for their valued service to the district.

The department is a combination paid/volunteer agency with paid firefighters as the primary manning being supported by volunteers. We are a professional organization embracing professional standards of conduct, training and response. We desire to provide the highest quality of trained staff available to respond to emergencies throughout the district in accordance with the limitations of a combination organization.

In order to achieve these goals, the department will expect each and every volunteer to comply with the following standards as adopted by the department. These will involve training, conduct, response and participation, attendance at district business and training sessions and such other as is required by policy.

#### **Initial Training Requirements**

All volunteer personnel who desire to respond to emergencies to provide - fire attack, suppression and/or investigation, render emergency medical care to victims of sudden illnesses and accidents, rescue from entrapments or hazardous environment and other responses where specific training is necessary, are required to successfully complete the appropriate training requirements (Firefighter Competency and/or Emergency Medical Responder) within the first 18 months of joining the department. **There are no exceptions.** If NO certifications have been completed within 12 months of joining the department, it will result in immediate removal. Volunteer applicants who wish to join as Support Members AND who will NOT be responding to emergency calls except to provide support to emergency responders, are only required to be certified in CPR.

Therefore, I, the undersigned volunteer agrees to complete all basic training as outlined above within the first 18 months of membership.

If I have any of the above certifications, or previous training which may be equivalent to the training requirement, I will provide verifiable evidence to the Fire Chief within 30 days of joining.

I agree to always drive safely, using good judgment at all times, whether related to the fire department or not.

I agree to <u>always</u> comply with all safety policies including the wearing of all appropriate personal protective equipment at all scenes where this is necessary as defined by the NOFD policy, procedure, guideline, or rule.

I agree to <u>always</u> treat others with respect and dignity at all times, even when under the stress of emergency scenes and environments.

Volunteer initials

I agree to meet my districts requirements for attendance at meetings and district training. I understand that my district may have requirements different from other area Fire Districts. I will attend no less than one-half of these sessions.

I further agree to spend an average of 20 hours a month at a manned district station accomplishing training and/or available to respond to emergency calls with paid employees.

I understand that I WILL NOT respond directly to any emergency scene unless authorized by the Fire Chief, nor will I be authorized to have ANY emergency lights in/on my personal vehicle without his/her prior approval.

I agree to be a positive force within the district, the department and my community.

I understand the chain of command and agree to follow it without exceptions.

I will **NOT** talk behind the back of any department member of any district at any time for any reason.

I understand, that as a volunteer, I can be removed from the volunteer roster at any time for any reason. I agree to immediately return all issued equipment if I am no longer a member of the North Okaloosa Fire District for any reason. This includes, but is not limited to, radios, pagers, badges, pins, brush gear, bunker gear, helmets, gloves, boots, pants, t-shirts, caps, bags, etc.

Lastly, I agree to always represent the North Okaloosa Fire District in a positive manner and will conduct myself in a manner which will not bring dishonor or embarrassment to the department. I have signed and agree to the NOFD Unacceptable Behavior Prohibited Agreement form, the Proprietary Information Statement and the Substance Abuse Consent Form.

I understand that the North Okaloosa Fire District will:

- Provide me with quality training and educational opportunities
- Provide me with appropriate uniform items to identify me as a member of the department
- Assist me in receiving the appropriate training requirements listed above
- Provide an opportunity to learn, serve and thrive
